#### **Rule 5 Personal & Ejection Fouls, Consistency With Coaches**

The penalty for a personal foul shall be suspension from the game of the offending player for one to three minutes, depending on the official's judgment of the severity and perceived intent of the personal foul The ball shall be given to the team fouled

**NBA RULES HISTORY**

A A personal foul shall be called and the ball shall be given to the opposing team at a point nearest to where the foul occurred B When the foul is the seventh or greater in a quarter or the fourth or greater in overtime, the penalty is the same as on any other personal foul and the fouled team shall take the required number of shots

Personal fouls always involve illegal contact and occur during a live ball, except a common foul by or on an airborne shooter The penalty for a single flagrant personal or flagrant technical foul is two free throws and disqualification plus awarding the ball to the opponents for a throw-in

(a) A foul against an official is not part of a Multiple Foul and will be enforced in addition to any other foul (b) If there is a personal foul that is also defensive pass interference, both fouls may be enforced AR 1410 Second-and-10 on A30 Runner A1 goes to the A35 During the run, A2 clipped on the A30 Team A was offside

**A QUICK GUIDE TO WATER POLO**

An exclusion foul is a "personal foul" ⇒ If a player receives three personal fouls (exclusion and/or penalty fouls), he/she is excluded from the remainder of the game with substitution ⇒ Examples of exclusion fouls include (but are not limited to): 1 Holding, sinking, or pulling back a player who is not holding the ball 1
